Appendix №1:

During the preparation for and conduct of the match between Xtreme Gaming and Team Resilience, members of Xtreme Gaming repeatedly failed to comply with instructions issued by the Match Referee and Floor Managers. Before the match, the Xtreme Gaming players were instructed several times not to place water bottles on the gaming tables. Although the players acknowledged the instruction by responding "OK", they continued placing the bottles on the tables and did not follow the requested procedure. Following the completion of the coin toss, the Xtreme Gaming players were instructed by the Match Referee and Floor Manager to leave the Field of Play so that the Sport Presentation could begin. Despite acknowledging the instruction, the players remained seated at their gaming stations and continued practicing for approximately 5 to 10 minutes. This delayed the established Sport Presentation procedure and demonstrated a failure to comply promptly with the instructions of competition officials. The Xtreme Gaming coach did not use the designated portal to enter the stage together with the players, despite having been informed in advance about the established stage-entry procedure. Before Team Resilience had completed its Sport Presentation, the coach attempted to enter the Field of Play. The Match Referee instructed the coach to wait, but the coach responded "no" and entered the Field of Play without authorization. Under section 3.2.3 of the Technical Rules, a coach is permitted on the Field of Play only during the picks and bans stage. Throughout the tournament, the Xtreme Gaming coach demonstrated that he understood basic English instructions and commands. In addition, a professional Chinese and English interpreter was present on the stage throughout the match and translated the instructions and requests issued by the Match Referee and Floor Managers for the Chinese-speaking team. The team had also been informed about the relevant stage procedures in advance. Therefore, the repeated failure to follow the instructions was not considered to be the result of a language barrier or misunderstanding. During the game, Xtreme Gaming players also removed technical pauses before receiving authorization from the Match Referee. The team was informed that the game could be resumed only after the opposing team had confirmed its readiness and the Match Referee had granted permission. Despite receiving instructions and warnings regarding this procedure, the players continued to unpause the game without referee authorization. Section 9.6.3 of the Technical Rules requires confirmation of the opposing team's readiness and permission from the Referee before a technical pause may be removed. The incident was recorded as repeated failure to comply with instructions issued by the Match Referee and Floor Managers, failure to follow the established Field of Play and Sport Presentation procedures, unauthorized entry of the coach to the Field of Play, and unauthorized removal of technical pauses.
